

# VOAI Terms of Use

**Last Updated:** November 15, 2025

These Terms of Use ("Terms") govern your access to and use of the VOA! application and services (collectively, the "Service"), provided by VOA! ("we," "us," or "our"). By accessing or using the Service, you agree to be bound by these Terms.

## 1. Acceptance of Terms

By creating an account, accessing, or using the Service, you agree to these Terms. If you do not agree to these Terms, you may not access or use the Service.

## 2. Changes to Terms

We reserve the right to modify these Terms at any time. We will notify you of any material changes by posting the new Terms on the Service or by other means. Your continued use of the Service after the effective date of the revised Terms constitutes your acceptance of the changes.

## 3. Eligibility and Accounts

- **Eligibility:** You must be at least 13 years old to use the Service. If you are under 18, you must have your parent or legal guardian's permission to use the Service.
- **Account Security:** You are responsible for maintaining the confidentiality of your account credentials and for all activities that occur under your account.

- To generate or disseminate content that is defamatory, obscene, pornographic, abusive, or otherwise objectionable.
- To infringe upon or violate our intellectual property rights or the intellectual property rights of others.
- To attempt to gain unauthorized access to the Service or its related systems or networks.
- To create content that is misleading, fraudulent, or deceptive, including impersonating any person or entity.
